Mission Statement: Jackson County United Way assesses needs, secures resources and strategically invests those resources to create measurable, lasting change in the areas of education, health, and financial stability for all people in Jackson County.



Designate a gift to one of United Way’s community partners: Any such gift will be among those “first dollars” that the United Way will be investing with that agency. Should there be more designations to any particular agency in a given year than what the United Way investment equals, that agency will receive the greater amount.

Designating to individual 501(c)3 nonprofit organization: To be eligible to receive your gift the agency must meet Jackson County United Way criteria based on 501(c)3 not-for-profit status and compliance with the USA Patriot Act. If a chosen agency is ineligible, or your information is incomplete or illegible, we will make every reasonable effort to contact you. If we are unable to reach you, your contribution will go toward the general campaign fund. Due to the cost of processing/distributing designations, your minimum gift should total at least \$52. A 10% processing and fundraising fee will be withheld to cover uncollectable pledges and processing costs on designations.
